

- Voluntary or court establishment of paternity Genetic Testing if not voluntary
- Administrative or court establishment of orders
- Interstate actions
- Enforce the order
 - Income withholding
 - Tax intercept
 - Drivers license suspension
 - Passport Denial
 - Court (jail as last resort)

Collect and disburse the money to families – reimburse State and Federal govt. for TANF














TOTAL PATERNITIES ESTABLISHED BY DCSE AND HOSPITAL PROGRAM




VIRGINIA DCSE SUPPORT ORDER MEASURE FOR TEN FEDERAL FISCAL YEARS






Virginia Division of Child Support Enforcement Source Of Child Support Collections For SFY10



TOTAL COLLECTIONS = \$633.2 MILLION


DCSE Collections vs. Caseload





DRIVERS' LICENSE SUSPENSION TOTAL COLLECTIONS




Child Support Received From Tax Offset
