# Code of Virginia 2.2-221.1



Directs the Secretary of Public Safety to establish an integrated system for coordinating the planning and provision of offender transitional and reentry services among and between state, local, and nonprofit agencies in order to prepare inmates for successful transition upon release from incarceration and for improving opportunities for treatment, employment, and housing while on subsequent probation, parole, or post-release supervision.

### National Governors Association Prisoner Reentry Policy Academy Initiative

- Virginia selected as one of seven states in Spring 2004
- Brought together team of experts from various agencies involved in reentry
- NGA provided guidance on developing effective prisoner reentry strategies designed to increase public safety while reducing the costs of recidivism
- Goal of improving transition programs and services
- Subcommittees established to focus on key areas and barriers to successful reentry



## Executive Order #22

June 2006

#### Established the Virginia Prisoner Reentry Policy Academy

- 1. Provide ongoing coordination at the executive level of reentry initiatives across the state
- 2. Explore programs that will aid with offender reintegration
- 3. Address policies and practices that impede successful reintegration
- 4. Work collaboratively to implement new policies and procedures
- 5. Submit a status report of actions taken to improve offender transitional and reentry services to the Governor and Chairmen of the House Appropriations and Senate Finance Committees no later than November 15 of each year.

- Grants to be announced in early 2007
