Please be advised that the time allotted for these public hearings will be limited to two and one-half hours. These constraints could limit the time that each speaker is granted, in order to enable as many speakers as possible to speak. The person presiding over the meeting will determine what time limits, if any, are imposed and will announce the guidelines at the beginning of the hearing.

Guidelines for making comment

- Be prepared to adapt your remarks to avoid making the same point made by previous speakers.
- Be prepared to answer questions that may be asked of you from the person presiding over the public hearing.
- Be prepared to have at least ONE COPY of your testimony to accompany your oral remarks. If the written testimony is lengthy, it is recommended that you quickly summarize the material in order that other speakers might be heard. Remember, written testimony will also be accepted in lieu of an oral presentation.
- Outbursts and remarks from the audience will be prohibited. Please make your remarks from the speaker's podium using the microphone.
