Part 1 – Suggested Components of Local PDR Programs

- Released June 2004

#### Components

- Clearly defined goals and purpose
- Action plan for outreach to land owners, public officials and the public

Part 1 – Suggested Components of Local PDR Programs (continued)

- Adopted ordinance/resolution establishing the program
- Valuation processes
- Agricultural enhancement strategy
- Deed of easement
- Mandatory monitoring program
- Periodic program evaluation
- Required reporting

Part 2a Proposed State Level Program to Complement Local PDR Program

- Release November 2005
- Role of the State PDR Program
  - 1) Certify local program as being operational
  - 2) Review/approve local applications for matching easement funds
  - 3) Disperse easement matching funds for qualifying local easement purchases

Part 2b Proposed State Level Program to Complement Local PDR Program

Strategic Plan

Goal: Enhance the viability of Virginia Agriculture & Forestry by facilitating local governments abilities to protect working farm and forest lands.

Objective 1. By 2007, the Commonwealth, through the Office of Farmland Preservation and public and private partners, shall have the capacity to provide farm and forest land assistance to all requesting localities.

- Proposed State Level Program to Complement Local PDR Program (continued)
- Objective 3: By 2010, 30 additional localities will establish PDR Programs consistent with State guidelines. By 2020, at least 70 total localities will have adopted and funded PDR programs consistent with the State model.


