- Secretary of Public Safety and Homeland Security to convene a work group consisting of relevant stakeholders to study the feasibility of establishing a centralized Continuity of Operations framework for state agencies
- Virginia Department of Emergency Management (VDEM), with the assistance of the Secure and Resilient Commonwealth Panel, to study of the state's reliance on grants for core emergency management functions
- VDEM to convene a work group to recommend a comprehensive legal and regulatory framework to take effect in event of an emergency



- Division of Purchases and Supply, in conjunction with the Department of Emergency Management, to design a dynamic stockpile strategy
- Expanding the exemption provided by Subdivision A(22) of Section 2.2-4343 of the code of Virginia to include suppliers and the types of tests that are needed.
- VDEM, in conjunction with the Virginia Information Technologies Agency, to establish a work group consisting of other relevant agencies and stakeholders to review technology service gaps existing during emergencies

- VDEM, in cooperation with the Department of Behavioral Health and Developmental Services, to develop standardized guidelines for mental health support during extended incident
- VDEM to develop a training program on National Incident Management System principles, the Incident Command System, and the role of the Emergency Operations Center. Agency heads would be required to attend the training within six months of appointment with additional training required at regular intervals
- Direct state agencies to develop a document for their agency outlining the Incident Command System and the role of the Virginia Emergency Support Team in the event of a declared emergency



- Chief Information Officer and the Virginia Information Technologies Agency, with the cooperation of the VDEM, to develop an emergency resource management system
- VDEM and the Department of Health (DOH) to study the existing emergency management regions and local health districts and recommend a mutually beneficial alignment
- VDEM to (i) offer health and safety training to volunteer organizations that are incorporated into the Virginia Emergency Support Team (VEST) and (ii) develop a health monitoring system for all volunteers incorporated into the VEST during times of emergency

# Legislation (4)/Budget Language (1)

- Amend § 22.1-272.2 of the Code of Virginia to include in the model memorandum of understanding procedures for providing the option for students to receive counseling from school counselors via telehealth.
- Codifying the Mental Health First Aid Trainings established in partnership between the Departments of Education and Behavioral Health and Developmental Services

# Legislation (4)/Budget Language (1)

- Department of Education to develop guidelines and information relating to virtual learning, including (i) statewide policies, (ii) the availability of online or virtual learning options, and (iii) guidelines for educators and schools relating to online or virtual learning policies and best practices
- Amend § 22.1-98 of the Code of Virginia to require that all schools in Virginia include in their annual safety audits comprehensive plans for school closures due to public health emergencies
- Budget amendment supporting the funding of individualized education program training and implementation. An estimated cost to support special education staffing needs for Level I Services is \$8.7 million.
