Americans bet over \$466 billion with unlicensed iGaming operators in the past year.



# SNAPSHOTS OF THE LEGAL IGAMING MARKET



New Jersey has generated over \$1.5 billion in additional tax revenue from iGaming since 2017.



Michigan has generated over **\$1.5 billion** in additional tax revenue from iGaming since 2021.



Pennsylvania has generated nearly **\$2 billion** in additional tax revenue from iGaming since 2020.


# VIRGINIA'S IGAMING OPPORTUNITY

Legalizing online casino gaming will generate an estimated **\$400 million annually** in new tax revenue.

Additionally, <u>millions</u> will be generated immediately from operator licensing fees.

### THE CASE FOR B&M CASINOS & iGAMING

As interest in online gaming grows, economists are increasingly studying how consumers interact with traditional B&M Casinos and online casinos.



Adults who play online are also regular customers at B&M casinos. Both can co-exist.



Adults visit a casino once-a-month or less. iGaming sessions occur more frequently but customers report spending similar amounts on both activities.

iGamers are generally younger, more educated and affluent than B&M casino gamers. B&Ms tout the benefits of iGaming sustaining their customer base.



# BY THE NUMBERS

Legalization of iGaming Shifts Players from Illegal to Regulated Markets



More than 60% of legal iGamers previously made bets in the illegal market or have played legally in other states.



Over 90% of illegal online gamblers transitioned their play to regulated markets when it became available in their state.


Legal online gaming operators use the same technologies as banks to ensure that only authorized persons can access their platforms.

# RESPONSIBLE GAMING TOOLS

Legal online gaming operators have integrated responsible gaming tools into their platforms to ensure customers are safe online.

These include:

- 1 DEPOSIT LIMITS
- 2 TIME LIMITS
- 3 WAGER AMOUNT LIMITS
- 4 COOLING OFF PERIODS
- Temporary or permanent SELF-EXCLUSION
- SUSPENDING OR CLOSING ACCOUNTS
